### REPRESENTATIVE EXPERIENCE

#### Energy

**Represented Enterprise Products at trial and in the appellate reversal in 2017 of a jury verdict of \$535 million dollars in a pipeline dispute against ETP.** The Dallas appeals court ruled in favor of Beck Redden client, Enterprise Products Partners LP, holding in a unanimous opinion that Dallas-based pipeline company ETP did not prove as a matter of law that Enterprise had waived conditions precedent to the formation of a partnership under Texas law in the context of a proposed crude oil pipeline project.

**Represented a leading gas company in multiple lawsuits arising out of gas supply contracts.** In 2010, Jeff tried a multimillion dollar case in Mississippi federal court. The trial involved claims that the firm's client breached multiple gas purchase contracts when Hurricanes Katrina and Rita disrupted natural gas supplies. After a weeklong trial, the court entered findings on the various claims largely in favor of the firm's client. Subsequently, the Fifth Circuit Court of Appeals reversed and rendered the sole adverse finding against Jeff's client, and the case was a complete victory. In 2011, for the same client, Jeff tried another multimillion dollar gas supply contract dispute in Texas state court. After a weeklong trial, the court entered a mistrial. Afterward, the case settled on favorable terms. Jeff tried these cases with partner David W. Jones.

**Successfully represented a national energy commodities brokerage firm against claims of RICO violations, negligence and breach of fiduciary duty.** Jeff led the defense, including undertaking all depositions, discovery and pre-trial motion practice. Jeff negotiated a favorable settlement for his client.

#### Fiduciary and Securities Litigation

**Represents individual shareholders of a leading global hair care products company** in defense of fiduciary duty claims brought by another shareholder seeking in excess of 10 million dollars.

**Represents a member of a prominent Texas family** in defense of fiduciary duty claims based on family trusts and foundations.

**In Houston federal court, Jeff represented a private equity investment company in defense of securities fraud and RICO claims** brought by an investor seeking more than \$10 million. Jeff represented the client along with attorneys from the Honigman Miller law firm. After the court dismissed the bulk of Plaintiffs' claims in favor of Jeff's clients, the case was settled on favorable terms.

**Represented various energy clients in cases involving securities fraud and derivative claims.**

#### **Products Liability/Personal Injury**

**Regularly represents one of the world's leading automotive safety component suppliers** in a large docket of product liability defect cases. Jeff has represented this client for more than 20 years in dozens of catastrophic personal injury and death cases pending in courts across the country, including Nevada, New Mexico, Virginia, and throughout Texas.

**Represented an international bolt manufacturer in a product defect case** in Galveston, Texas. As lead counsel, Jeff directed an extensive failure investigation, depositions, and motion practice. Eventually the plaintiffs voluntarily dismissed Jeff's client from the case.

**Represented a leading Midwestern steel fastener manufacturer and supplier in a product defect case** in Waco, Texas. The court granted summary judgment for Jeff's client and dismissed all claims.

**Represented another national steel fastener supplier** in Beaumont, Texas. After extensive discovery and investigation, Jeff filed motions for summary judgment, and the plaintiffs promptly dismissed Jeff's client from the case.

#### **Real Estate/Construction**

**In 2015, represented a luxury high-rise penthouse purchaser in an arbitration dispute with the building developer over the terms of the purchase agreement.** After a multi-day hearing, the arbitrator ruled in favor of Jeff's client by ordering the developer to construct the penthouse in accordance with the purchaser's custom architectural plans. The arbitrator denied the developer's counterclaim alleging breach of, and seeking termination of, the purchase agreement.

**Represented a modular school building contractor in a contract dispute with a local charter school relating to permitting and nonpayment claims.** The case was settled on favorable terms.

#### **Trade Secrets**

**Represented an international corporate client in a trial involving alleged breach of non-solicitation agreements and theft of trade secrets.** After a weeklong trial in Dallas,

the jury rendered a verdict for the Firm's client on all issues. Jeff tried the case with partner Joe W. Redden.

**Represented a Fortune 500 company that designs health care software information and management systems in multiple lawsuits.** Jeff's client faced multiple claims of breach of contract, warranty and deceptive trade practices arising out of the performance of the software. After an investigation, depositions, and pre-trial matters, Jeff negotiated a settlement on favorable terms.

**Regularly represents companies and individuals in employment disputes relating to ERISA, trade secrets, covenants not to compete and nonsolicitation agreements.**

### **Professional Liability**

**In Austin federal court, represented an AM LAW 100 Texas law firm in a professional liability case** in which the plaintiffs sought damages in excess of \$170 million. The court granted summary judgment in favor of Jeff's client, which was affirmed on appeal.

**In Mississippi federal court, represented a 500+ attorney Texas law firm in a professional liability case.** The plaintiffs sought damages in excess of \$200 million. The plaintiffs alleged that the firm's client breached fiduciary duties arising out of their legal work on a merger between publicly traded construction companies. Jeff led the defense by undertaking extensive investigation, discovery, depositions and motion practice. Eventually, Jeff negotiated a favorable settlement.

**Represented an international law firm in a professional liability case** in which the plaintiffs alleged negligence in the handling of a family law matter. After Jeff led discovery and pretrial matters, he negotiated a favorable settlement.

### **Insurance/Technology DNA Testing**

**Represented the insured, Gene by Gene, Ltd., a web-based DNA testing company headquartered in Houston.** Gene by Gene was sued in Alaska federal district court in a putative class action based on claims it violated Alaska genetic privacy laws. Gene by Gene sought coverage (defense and indemnity) for the Alaska claims under insurance policies underwritten by Evanston Insurance Company. Evanston denied coverage and filed a lawsuit in Federal District Court in Houston, seeking a declaration of no coverage based on a policy exclusion. Gene by Gene counterclaimed seeking a declaration that the Alaska claims are covered by the Evanston policies and alleging violations of the Texas Insurance Code. The Court granted summary judgment to Gene by Gene on all of its claims and held: (1) the Alaska case is covered, (2) Evanston must defend and indemnify Gene by Gene in Alaska, (3) Evanston breached the insurance contracts, and (4) Evanston violated the Texas Insurance Code. Damages briefing is pending.
